The rate listed in this tariff is applicable on the Canadian movement only of Light Condensate tendered at a receiving point in Canada, and is payable in the currency identified with the rate. The movement in the United States is subject to tariffs published by Pembina Cochin LLC which are filed with the Federal Energy Regulatory Commission in the United States.
